Number of stall required:1

The stall shall be of wooden platform with LED skirting, vinyl finished flooring. It should be single storied, self standing & shall not affect the structures of other stalls. The customized structure should not be compromised in quality & Strength. Minimum height of the stall should be 4 meters. Height of the periphery walls may be restricted as per the organizer guidelines. Stall must be provided with sufficient lighting according to the design and include required electrical fittings. Fascia Names shall be with background light.

Provide small ramp for wheel chair access if required according to the design. Access must be given to any Fire Exit, Electrical box, Service room, etc. falling within the exhibitor's stand area. Design must have Stall Number Signage Board. The stall must be designed with reception frontage, area for Spices Board & remaining portion shall be equally divided for 25 co participants.

Co participant area

Number of co participant booths required:25

25 individual booths shall be there in the stall for accommodating 25 co participants with following facilities. How ever it may also be noted that Spice Board will have the right to increase or decrease the number of co participant booths during the time of Award of Contract & the fabrication should be according to the final decision of Board.

- Glass top counter table with a branding provision.
- 4 chairs for each exporter. Brochure stand.
- Fascia Names (With background light).
- Full size branding options in all panels and counter tables.

Spices Board's area

The stall must have a well decorated reception area. The area of Spices Board must have the following facilities.

- VIP seating arrangement [Sofa set (one 3 seater + one 2 seater)]
- Discussion area with 5 round tables and 20 chairs
- Coffee table
- LED TV
- Water dispenser- 2 Nos.
- Tea/coffee wending machine with ingredients
- Reception counter
- Glass Showcase for display of spice products.
- Store room
- Brochure stand
- Full size branding in common area.

Stall fabricator should ensure sufficient number of staff in the event venue from the beginning to the end of the exhibition for managing the stall and extending any sort of assistance as directed by the Spice Board's designated staff for the particular event.

After receiving the work order, stall designer must immediately contact the exhibition organizer for initiating the fabrication works. The stall designer should be fully aware of all construction and decoration regulations at Ashoka Hotel, New Delhi, India.

It is the sole responsibility of the selected stall designer to fill up the mandatory forms & obtain approval for design from the organizer before the commencement of erection. The stall fabrication should be in compliance with the organizer guidelines for stand construction. It will be the responsibility of the stall fabricator to remit any security deposit demanded by the organizer in connection with the event.

The stall designer shall use prefabricated structures to prevent delays in stall completion and to avoid causing inconvenience to other exhibitors. All electrical installations and wiring must be carried out by a licensed electrician. Utmost care should be taken to refrain from causing any deformation or damage to the exhibition hall during the set-up of the stall.

The electricity payment shall be remitted by the stall designer and later get it reimbursed on submission of proper tax invoice.
